Judging:

There were about 25 people in attendance at the judges clinic this year. Blaise handed out a voucher along with a description of the shadowing program for new judges. Blaise also emailed Howie Sokol about aggressively pairing new judges with veteran judges to help facilitate the program. New judges will receive emails and phone calls about shadowing opportunities. They will be paid through the association. Blaise Blasko discussed two different levels of judging (I and II).

This Thursday, February 25, there will be a follow up clinic for more basic judging (Level I). The clinic will be start at 7:00 PM at Glenbard West High School. The purpose of the clinic will be to spend time identifying, naming and assigning values to a multitude of skills. They will also discuss what skills accurately satisfy specific requirements.

 This will be discussed and voted upon at the March meeting.

The proposal was withdrawn by Steve Foerch when it was realized there was no constitutional proposal needed for this change to take effect. The constitution stated that the nominations are due in April. The IHSGCA decided the nominations will be due at the April meeting. The selection committee will also vote and decide the All-star team at the April meeting.
